1. Purpose and Scope

Trust depends not only on continuity of office, but on coherence of narrative and visible adherence to lawful process.

9. Tensions Within Public Doctrine

Several tensions appear:

- speed vs. legitimacy
- centralization vs. resilience
- clarity vs. flexibility

Public doctrine often leaves these unresolved.

10. Interpretive Gaps

Public materials are often silent on:

- prolonged ambiguity
- overlapping authority claims
- public perception under sustained uncertainty

This silence may be intentional.

11. Non-Binding Observations

From an interpretive standpoint:

- continuity is as much perceptual as operational
- prolonged stress poses distinct risks
- lawful process often outranks efficiency

These are observations, not judgments.

12. Limits of This Review

This paper does not predict behavior, assess readiness, or evaluate institutions. It clarifies what public doctrine addresses—and what it leaves open.
